STUDENT SHORT-TERM PROMISSORY NOTE

I understand that any unpaid balance on my account may prevent me from enrolling, or subject me to being dropped from classes, in-line with established University payment deadlines. I make this note subject to the following conditions:

1. I, my sureties, guarantors, heirs, and legal representatives, severally waive demand, presentation for payment, notice of protest, and diligence in collecting or in bring suit.
2. I may repay all or any part of the principle at any before maturity.
3. I agree to inform the Office of Student Financial Services of any change in my address until this note is paid.
4. If I am awarded student financial aid subsequent to the origin of this note, it will be applied first to my outstanding indebtedness.
5. I agree to pay a Short-Term Loan processing fee of five (5) dollars at the time of origination of this note.
6. If I default in the payment of this note, I may be subject the following actions:
 - a. The entire unpaid principle balance, together with accrued interest, shall be paid immediately.
 - b. The outstanding amount will be charged to my student account, all university services will be severed, and I will be charged a fee of fifty (50) dollars to restore such services.
 - c. My account may be assigned to a collection agency and a collection fee of 25% of the outstanding account balance will be added to my student account balance at the time of referral.
 - d. My account may be referred to attorneys, in which event I agree to pay reasonable fees, costs of court, and any other costs and expenses associated with collecting the unpaid balance.
 - e. I will lose my eligibility status for future such loans.
