WHAT IS THE HAZLEWOOD ACT?

- THE HAZLEWOOD ACT IS A STATE OF TEXAS BENEFIT THAT PROVIDES QUALIFIED VETERANS, SPOUSES, AND DEPENDENT CHILDREN WITH AN EDUCATION BENEFIT OF UP TO 150 CREDIT HOURS OF TUITION EXEMPTION, INCLUDING MOST FEE CHARGES, AT PUBLIC INSTITUTIONS OF HIGHER EDUCATION IN TEXAS.
- THIS DOES NOT INCLUDE LIVING EXPENSES, BOOKS, DEPOSITS, SUPPLY FEES, LATE REGISTRATION FEES, STUDY ABROAD COURSES, EXECUTIVE PROGRAM FEE, THE STUDENT SERVICES FEE ETC.

HAZLEWOOD ELIGIBILITY

STUDENTS CAN FALL INTO 3 CATEGORIES (VETERAN, LEGACY CHILD OR DEPENDENT/SPOUSE). **SEE BELOW FOR ELIGIBILITY DETAILS FOR EACH CATEGORY**.

- RECIPIENTS MUST BE IN A DEGREE SEEKING PROGRAM, ENROLLED IN STATE-FUNDED COURSES.
- ALL STUDENTS MUST MEET THE GPA REQUIREMENTS OF UH'S SATISFACTORY ACADEMIC PROGRESS (SAP).
- FIRST-TIME RECIPIENTS HERE AT THE UNIVERSITY OF HOUSTON, (INCLUDING TRANSFER STUDENTS) MUST TURN IN A COMPLETE INITIAL APPLICATION, WITH ALL SUPPORTING DOCUMENTS, BY THE LAST DAY OF THE SEMESTER IN WHICH THEY INTEND TO USE THE EXEMPTION.
- PREVIOUS RECIPIENTS HERE AT THE UNIVERSITY HOUSTON, MUST COMPLETE A CONTINUED ENROLLMENT FORM ONLY, BY THE LAST DAY OF THE SEMESTER IN WHICH THEY INTEND TO USE THE EXEMPTION.

PREVIOUS ELIGIBILITY FROM OTHER INSTITUTIONS DO NOT AUTOMATICALLY GUARANTEE THE EXEMPTION. ELIGIBILITY IS DETERMINED BY APPLYING AND SUBMITTING THE REQUIRED DOCUMENTATION .



VETERANS SEEKING TO USE THE HAZLEWOOD EXEMPTION MUST MEET ALL THE FOLLOWING:

- VETERAN WAS A RESIDENT OF TEXAS AT THE TIME THE VETERAN ENTERED THE SERVICE; OR DESIGNATED TEXAS AS HOME OF RECORD; OR ENTERED THE SERVICE IN TEXAS
- DISCHARGED FROM MILITARY UNDER HONORABLE OR GENERAL CONDITIONS.
- SERVED AT LEAST 181 DAYS (6 MONTHS) OF ACTIVE-DUTY SERVICE (EXCLUDING INITIAL ENTRY TRAINING).
- CURRENTLY RESIDE IN TEXAS.
- HAVE NO FEDERAL VA BENEFITS (CH 31 OR CH 33) DEDICATED TO TOTAL PAYMENT OF TUITION & FEES.

LEGACY CHILD VETERAN SHARING BENEFIT WITH CHILD

CHILDREN OF A VETERAN SEEKING TO USE LEGACY HAZLEWOOD EXEMPTION MUST MEET ALL THE FOLLOWING:

- BE A CHILD OF A VETERAN WHO MEETS **ALL** OF THE ELIGIBILITY REQUIREMENTS FOR VETERANS DESCRIBED ABOVE AND VETERAN ASSIGNS THEIR UNUSED HOURS OF EXEMPTION TO THEM
- BE 25 YEARS OF AGE OR YOUNGER ON THE FIRST DAY OF THE SEMESTER
- BE CLASSIFIED BY UH AS A RESIDENT OF TEXAS AND VETERAN MUST RESIDE IN TEXAS
- HAVE NO FEDERAL VA BENEFITS (CH 31 OR CH 33) DEDICATED TO TOTAL PAYMENT OF TUITION & FEES

PLEASE NOTE: ONLY ONE PERSON CAN USE THESE BENEFITS AT A TIME. ELIGIBLE VETERANS CAN USE IT THEMSELVES OR ASSIGN BENEFITS TO ONE DEPENDENT PER SEMESTER. TWO PEOPLE CANNOT USE THE LEGACY BENEFIT FROM THE SAME VETERAN IN THE SAME SEMESTER.

DEPENDENT/SPOUSE VETERAN IS 100% DISABLED; KIA; MIA

SPOUSE OR CHILD OF A VETERAN SEEKING TO USE HAZLEWOOD EXEMPTION MUST MEET ALL THE FOLLOWING:

- BE A SPOUSE/CHILD OF A VETERAN WHO MEETS ALL OF THE ELIGIBILITY REQUIREMENTS FOR VETERANS DESCRIBED ABOVE AND:
 - YOUR VETERAN IS TOTALLY AND PERMANENTLY DISABLED OR MEETS THE ELIGIBILITY REQUIREMENTS FOR INDIVIDUAL UNEMPLOYMENT OR;
 - YOUR VETERAN IS MISSING IN ACTION; OR KILLED IN ACTION
 - YOUR VETERAN'S DEATH IS DOCUMENTED TO BE DIRECTLY CAUSED BY ILLNESS OR INJURY RELATED TO SERVICE IN THE ARMED FORCES OF THE UNITED STATES.
- BE CLASSIFIED BY UH AS A RESIDENT OF TEXAS.
- HAVE NO FEDERAL VA BENEFITS (CH 31 OR CH 33) DEDICATED TO TOTAL PAYMENT OF TUITION & FEES



- "STACKING" RELATES TO USING BOTH FEDERAL (VETERAN AFFAIRS) AND STATE (THE HAZLEWOOD ACT) BENEFITS.
- THIS IS PERMITTED IF THE VETERAN IS ELIGIBLE FOR LESS THAT 100% OF POST-9/11 GI BILL[®] (CHAPTER 33) AS DENOTED BY THEIR CERTIFICATE OF ELIGIBILITY (COE).
- EXAMPLE: IF VETERAN'S COE STATES 60% ELIGIBILITY FOR POST 9/11, HAZLEWOOD MAY COVER THE DIFFERENCE (40%) OF QUALIFIED TUITION AND FEES.
- FEDERAL VA BENEFITS MUST BE USED FIRST.

PLEASE NOTE: THIS REQUIRES THE RECIPIENT TO RENEW THE HAZLEWOOD EXEMPTION EACH SEMESTER THEY LIKE TO HAVE IT APPLIED.

- VETERAN'S VA DISABILITY RATING DECISION LETTER SHOWING VETERAN 100% TOTAL AND PERMANENT STATUS.

HAZLEWOOD ACT

HOW HAZLEWOOD APPLIES:

AFTER THE RECIPIENT'S ENROLLMENT IS COMPLETED, THE HAZLEWOOD ACT WILL BE APPLIED TO THE SEMESTER'S FEE BILL AS A WAIVER. THE HAZLEWOOD ACT IS APPLICABLE FOR ALL SEMESTERS (FALL, SPRING AND SUMMER). A RENEWAL (HAZLEWOOD CONTINUED ENROLLMENT FORM) IS NEEDED ONCE A YEAR. *UNLESS THE STUDENT IS ENROLLED IN A SPECIAL PROGRAM OR STACKING WITH VA BENEFITS.

EXAMPLE: IF THE RECIPIENT WAS APPROVED IN THE FALL, THEN EACH FALL TERM ONLY, A RENEWAL FORM IS NEEDED. IF THE RECIPIENT WAS APPROVED IN THE SPRING, THEN EACH SPRING TERM, ONLY A RENEWAL FORM IS NEEDED. RECIPIENTS WHO STACK BENEFITS MUST RENEW EACH SEMESTER.

- THE HAZLEWOOD EXEMPTION WILL NOT APPLY IF THE RECIPIENT IS NOT ACTIVELY ENROLLED.
- IF RECIPIENT DROPS COURSE[S] AFTER THE CENSUS DATE AND RECEIVES A "W" GRADE, THOSE HOURS WILL STILL COUNT AGAINST THE HAZLEWOOD 150 CREDIT HOUR LIMIT.
